

## Mental Health Assessors - Qualification and Refresher Course



The introduction of the Deprivation of Liberty Safeguards brought with it the role of Mental Health Assessor (MH Assessor). A MH Assessor is a role undertaken by doctors and is crucial in ensuring that compliance with the legal criteria of DoLS is satisfied but this role also brings with it significant responsibilities as the assessments may be scrutinised by the Court of Protection and higher courts.

This course will ensure MH Assessors are suitably qualified to cover the assessments they will have to undertake as part of their role and give them the confidence to complete the DoLS paper work. The focus will be on Mental Capacity, Eligibility and Mental Disorder Assessments, being the key assessments undertaken by these assessors. The latest DoLS forms and DoLS process will be included in the course.

For those who have already qualified, the course will serve as a detailed legal refresher incorporating the latest relevant case law enabling them to continue in their role.

**Due to the advanced nature of this course, it is imperative that those attending already have prior knowledge of the basics of the:**

- Mental Health Act 1983 (as amended)
- Mental Capacity Act 2005
- Deprivation of Liberty Safeguards

There will be insufficient time to go through these large areas of law in addition to the specific requirements of the MH Assessor role. We provide separate full day basic awareness training on each of the above subjects.
